SECOND GENERATION JUSTICE GREULE RETIRES THIRD GENERATION JUSTICE GREULE TAKES OFFICE



The Honorable Edward Snyder was a Justice and father of Kathleen Greule. He was the first of their blood line to enter into the esteemed position of Justice. Donald R. Greule, deceased husband of Kathleen Greule, was a fair and honorable justice for many years in the Village of Interlaken. Kathy was the first woman to serve on the Village of Interlaken Board and also served as their Village Clerk. While residing in the Village of Interlaken, she became a member of the Interlaken American Legion. Twelve and a half years ago, our town was honored to have second generation Justice, Kathleen Greule Yells preside for the Town of Romulus.

As of December 31, 2007 she retired for the second time in her lifetime, fulfilling yet another great endeavor and will forever be known as one of the finest in Seneca County. Justice Kathleen Greule retired the first time from Willard State Hospital as a registered nurse. She was a past board member of the Seneca County American Red Cross and taught CPR. She was also on the Disaster Action Team.

We wanted to share with you, how dedicated and devoted Kathy is and has been to our town and this county. She has a soft spot for children. She is a member and past President of the Seneca County Children's Committee and also a member of the Seneca County Youth Bureau. She is a member of the Seneca County and the New York State Magistrates Associations. Most important, she is a cancer survivor and a relay for life volunteer. One of her most important accomplishments is being a dedicated loving wife, mother of two and grandmother of three.

As of January 1, 2008, Kathy's son, Donald E. Greule, sits as the third generation Justice of their bloodline and second generation Justice for the Town of Romulus. With both parents serving as justices, it appears inevitable that one of their children would follow in their footsteps.

The Honorable Donald E. Greule has been married to Yvonne (VanCamp) Greule for 23 years. They have three children, Kristopher, Kate and Don. The bets are out on which of these three will become the fourth generation Justice. Don and his family have lived their entire lives in Seneca County. He and his wife are South Seneca high school graduates. Don is a 1985 graduate from Alfred State College. Like his parents, he wears many hats. He is a member of the New York State and Seneca County Magistrates Association, the Hernon Park Committee, and became a local fire fighter of Ovid in 1986 and recently resumed this position with the Ovid Fire Dept.

The Town of Romulus Court Clerk, Terri Sandifur will be staying on to assist our new justice, just as she has for the prior fourteen years for the Honorable Kathleen Greule and before her the Honorable Margaret Ellsworth.

However, the court schedule has changed. Town of Romulus Court will be held on Fridays at 10:00 a.m. rather than Wednesdays. All telephone numbers, email and mailing addresses will remain the same.

New York State Agricultural College

The New York State Agricultural College at what is now known as Willard, was the first chartered agricultural college in New York State. It was incorporated by the New York State Legislature on April 15, 1853. The college opened December 5, 1860, on a slightly less than 700 acres of farmland just west of the Village of Ovid. The course of study was a three year program of classroom instruction and practical farm experience. Hundreds of Seneca County residents and New York State citizens gave a total of approximately \$47,000.00 in a local subscription effort to make this Agricultural College a reality.

The start of the Civil War led to the departure of several staff and students. In March 1862, the college trustees declared that the college was temporarily closed. It was their assumption that once the Civil War was over, the college would reopen. Events during and right after the war, however, kept this reopening from taking place. The U.S. Congress had passed the Morrill Land-Grant College Act in 1862, and the New York State Legislature awarded our state's land grant for the teaching of agricultural and mechanical arts to the newly-established Cornell University at Ithaca.

In 1865, the New York State Legislature created the Willard Asylum for the Insane and provided for its location on the property the State acquired form the bankrupt Agricultural College. The Agricultural College building was later opened as The Branch of the Willard Asylum. The Branch was still later greatly enlarged and became known as The Grandview. Today this building is part of the Willard Drug Treatment Campus.

The Historical Societies form Interlaken, Lodi, Ovid and Romulus together with the Seneca County Historian have been working together to make the public aware of the great history we have right here in our own back yards. This group has worked to preserve our history by designating this location with a historic marker that signifies it is an area of interest. The committee members of the various historical societies have ordered this marker and would like to inform the public of its official unveiling. The details are outlined below, along with a sneak preview of what a marker of history may very well look like. Although the wording will be different than what is on the plaques shown as an example.



Economic development projects are continuing toward fruition at the former Seneca Army Depot. Within the past month, we witnessed the ribbon cutting of the Hay Processors, Inc. on the depot and very soon there will be another formal ceremony welcoming the Seneca BioEnergy, Inc. to another area of the depot.

We have jointly applied with the Town of Varick for grant funding through New York State's Safe Routes to School program in hopes that we will be selected as the recipients of this grant so that we can complete our endeavor of providing sidewalks the distance of the Main Street in the Hamlet of Romulus. Once this area is completed our next focus will be on replacing and repairing sidewalks in the Hamlet of Willard along County Roads 132 and 132A.

As the year moves forward, we will be seeking your input regarding the lakefront in Willard. We have been working with the Willard Drug Treatment Campus in an effort to clean up this area and provide a view of Seneca Lake. Corrections has done a phenomenal job of clearing debris and brush in a vast section of this area. We have recently received notification that we will be receiving a "Lakeshore Revision Grant" which is funding that allows us to design a plan for this area. We will be looking for your input and again working with Department of Corrections to attempt to work towards improving this area.

The Town of Romulus is nearing the final steps of acquiring the former Recreation Center, pavilion and playground at the former Seneca Army Depot for the use and enjoyment of the community. We appreciate the generosity of Aspen Square Management for donating this property to the Town of Romulus for this purpose.

I have really enjoyed working with all of you in our quest to make Romulus a better place to live. Your input is appreciated and valuable to all of us representing you, even if we do not always agree. Please feel welcome to participate in our various community groups and projects.

There is an insert in this newsletter, that I would greatly appreciate residents taking a few minutes to fill out. Some of you have been kind enough to submit your thoughts in the past and I would like to encourage you to continue to do so. We realize in today's world all of our lives are busy and we don't always have time to attend meetings and address issues of concern. Seneca County Sheriff's Department Launches New Program "SEX OFFENDER WATCH"

Sheriff Jack Stenberg with the assistance of Waterloo Police Chief; Doyle Marquart and Seneca Falls Police Chief: Frederick Capozzi has launched a new program called Offender Watch. The program is an internet based, citizen friendly, easy to use, Seneca County sex offender registry. The program allows citizens to search for the presence of registered sex offenders and predators in Seneca County. Citizens may enter any address of interest to them and see a map and listing of offenders within one mile of that address. Then they may register the address to be continuously monitored by the Sheriff's Office, Waterloo P.D. and Seneca Falls P.D. The new computer system will send to them an email alerting them if an offender or predator should move within one mile of their registered address. Citizens may confidentially register as many addresses as they wish such as; homes, place of work, day cares, schools or any place that children frequent. This automatic notification service is provided free of charge. Citizens may also search for offenders by name or obtain a list of all registered sex offenders in Seneca County. If a citizen wants information on an offender they can simply click on the individual's name and receive all the information, including photos that can be legally released.

This program also enables the Sheriff's Office and the local police departments to verify that offender addresses do not violate any proximity laws around protected institutions in the county and villages such as schools, registered day cares, certain parks and other locations. Working together the Sheriff and the Police Chiefs are using this program, not only to keep citizens informed, but to enhance their ability to manage registered offenders and enforce all violations. Officers from the Sheriff's Office and Village P.D.'s are pro-actively verifying the addresses of registered offenders on a regular basis to insure compliance.

Citizens are encouraged to use this free program and register for E-mail alerts. The Offender Watch home page also contains valuable information about sex offenders and how to protect our children. There is also an internet presentation available on the home page to help citizens become familiar with the program.
