# **Approval of Minutes:**

#### **Petitioners to the Board:**

William Casey McDonald of 1960 Seneca Street in the Hamlet of Romulus addressed the board with reference to a letter that he has not yet received regarding a violation of the Zoning Law. Mr. McDonald points out the definition of agricultural use as stated in the Town of Romulus Zoning. After reading the definition. Mr. McDonald did not feel that he is in violation. however he stated that if the board feels that it is in deed a violation he would comply. The Zoning Officer recommended Mr. McDonald takes his findings to the Zoning Board of Appeals on May 12<sup>th</sup> at 7:00 p.m. for a determination of whether a special use permit will be required or not. Mr. McDonald inquired about the Zoning Officer's findings with this new information. Lee explained that he does see where there is some discrepancy and stands with his thoughts of having this brought before the Zoning Board of Appeals. Mr. McDonald was under the impression the Town Board would make the decision. Supervisor Kaiser explained the proper process to Mr. McDonald. The Town Board does not determine whether a property is in violation or not, but rather the Zoning Board of Appeals. Lee explained that this board could also over turn his findings. Mr. McDonald requested the Zoning Officer respond to the 25 or so junk vehicles that are presently located at 1968 Seneca Street, as he feels they are clearly in violation of the Zoning Law. David

Kaiser assured Mr. McDonald the Zoning Officer would look into this and a response of their findings would be sent to Mr. McDonald in the form of a letter. Mr. McDonald inquired about the possibility of the animals being allowed to reside on his property until the findings of the Zoning Board of Appeals on the 12<sup>th</sup> of May. Mr. Kaiser told Mr. McDonald that we would need to discuss this with our Town Attorney and the Zoning Board to determine if he will be allowed to keep the animals there until the 12<sup>th</sup> or if they must be removed by the 25<sup>th</sup> of April. He will provide Mr. McDonald with a decision regarding this by Monday the 25<sup>th</sup> of April. The board will authorize permission to advertise for a public hearing for the Board of Appeals with regard to Mr. McDonald's situation.

- a. Verbally Lee reported the Planning Board is working on including the Trailer Park Ordinance in the Zoning Law. With reference to Mr. Standish's request to add another mobile home unit to his property, the Planning Board Chairman has interpreted the Zoning Law and Mobile Home Ordinance as follows: Mr. Standish may keep the four existing mobile homes as they are, as long as the fifth trailer is not used for occupancy and only as a form of a shed. However, if Mr. Standish's intention is to use this mobile home as a residential building than all five trailers must comply with the Mobile Home Ordinance. It is recommended that Mr. Standish insert his purpose for this mobile home on his application in writing.
- b. A letter was sent to Mr. McCloskey with reference to removing the debris on his property. Lee assured the board that this has been done.

## Supervisor's Report -

- a. Dave has run a disc over the Hernon Park property that was plowed up last vear.
- b. Dave reported to the board and residents that the security camera with audio, which was requested by the court, has been installed.
- c. The Seneca County Jail project will begin next week. They hope to have the ground breaking in early May of 2005.

## **Committee Reports:**

- a. Hernon Park next meeting will be April 27<sup>th</sup>, 2005 at 9:00 a.m.
- b. <u>Romulus/Varick Joint Meeting</u> went well. The minutes did not reflect Supervisor Kaiser as being present at the meeting. However he was in attendance for that meeting and the minutes would be corrected to show this information.
- c. Route 89 Water Project Received a notice from Joan Teichner, Varick's Supervisor, requesting we submit a questionnaire to our residents regarding this project. Dave Kaiser would like to delay responding to Ms. Teichner until he has had the opportunity to speak with Ken Riemer about this.
- d. South Seneca Ambulance Meeting Councilman Ritchie felt the facts and figures were substantial. Paul DeGary informed the members and audience that they have been able to save money and we may see a decrease in the charge per parcel to \$25.00 per parcel. The ambulance corp. has obtained better contracts with the prison, now have less cost of employment wages and more volunteers. All have contributed to the means for saving money.
- e. Building and Grounds Committee
  - i. A meeting was held to determine which estimate to accept for the *replacement of the windows* at the Town Hall. It was decided the bid would be given to Seneca Vinyl of Romulus. They expect to begin installation of the windows by the first part of June 2005.

- ii. *Vending machine* estimates were gathered and reviewed. It was decided this particular venue wasn't as imperative as the others and we would wait another year and re-evaluate this again.
- iii. *Christmas decorations* are being considered as a possibility for light poles in the three hamlets. It was discussed; we should start with a minimum of 5 decorations per hamlet and perhaps add to this decoration program each year, until we have accomplished our goal.

#### **Old Business:**

- a. Councilman Gerlach asked if anything is being done with regard to the holes In front of the Episcopal Church and also the hole in front of Kathyrn Fisher's home. Dave Kaiser explained that he has spoken with Roy Gates regarding both of these locations. Roy assured him this would be taken care of as soon as possible. Ralph Walborn, Jr. spoke with Jim Rapalee and he told Ralph that he would be inspecting the situation and reporting back to Roy with his findings.
- b. Councilman Gerlach inquired about the Dickens property. Lee Hoaglan explained that George did not meet the April 15<sup>th</sup> deadline, therefore the County Health Dept. will be issuing a summons for court to Mr. Dickens. The town will step aside while the County is in pursuant of this, as the County is a stronger entity than the Town. The court date is scheduled for May 11, 2005. Marty Brewer told David that he would be purchasing the property. He explained that the East house is secure and propane tanks have been removed. The west house is scheduled to burn by the Fire Dept. in 2 weeks. Lee understood the fire department is planning to use this house for fire practice on Tuesday.
- c. Dumpster Days for June is the 17<sup>th</sup> through the 19<sup>th</sup> and October is the 8<sup>th</sup> Through 10<sup>th</sup>. The newsletter reflected the dates incorrectly, however the actual permit tickets are correct. Each permit holder will be allowed 8 trips in June and 8 more in October. Dave let the board and residents know there is a shelter now at the dumpster days premises for our workers to get out of the weather.
