The Proposed notification Plan was discussed with Angel Lawrence and Mary Farnsworth to see what was needed for this form. The attached form is the combined effort of all to be easy enough for everybody to use. There is also a page of instructions to be with it. This form will have to be filled out and notarized and filed with the Planning Board. Supervisor Kaiser read the instructions to everyone. A question was asked concerning # 7 on the instruction sheet about listing any neighbors that were not contacted. Some people go away for the winter etc and would not be able to even try to be contacted. What would happen in that case? Dave Hayes, Code Enforcement Officer stated that "according to the way the variances were, there is a lot of consideration taken in the way that the decision is made. Just the fact that the neighbor does not want it does not negate the fact that they can't have it. They have to show that there has to be just cause for whatever they are applying for, whether there is an area variance or use variance. There has to be substantial reason why. They have to meet the criteria for any variances. There are restrictions that can be put on a variance. " John and Helen Dunbar wanted to have their cell phone number put on record in case they need to be contacted by someone regarding a variance. Mr. Dunbar asked if "someone was requesting a variance if they had 45 days from the time that they requested this variance to have the work completed?" The answer was "no" that was to get an answer. They have one year to have the majority of the work completed. There is also a time period in which a variance can be contested. The time period is 90 days. a request for a variance, someone should contact him. The person applying for variance should come into the office and find out who the neighbors are. Mr. Jordan liked the new for but wished there was someway to firm up the effort to contact all the neighbors. Would like to see the Planning Board representative try to contact neighbors and that way would have an impartial party trying to make the contact rather than the person directly involved in the variance. Supervisor Kaiser asked Planning Board to adopt this procedure but not to consider this a done deal. The Board will continue to take any input and Supervisor Kaiser encouraged the Boards to look into what the other towns are doing. Helen Dunbar brought up the fact that if there a notice of a Public Hearing, and we might be in Texas, would a registered letter or something in lieu of us being here be acceptable. Just write a letter say how you feel and have your signature notarized that you are the person signing that letter.

The Town Board accepted this new form for notifying neighbors about any variances with stipulation that any changes will be made if necessary.
