The big grinder was available last week and Roy Gates, Highway Superintendent wanted to grind a section of the County Road. The Town Section and the Village section were done on Monday. It will now be oiled and stoned before the bicycle race. If not it will still be a very tight road. Mr. Williamson said "the county talked with me on Tuesday about County Road 129 and Swick Road where the intersection has two holes in it. We fixed those holes. When the blacktopping is done in three weeks they will do this intersection also. A drain was also put in. Poplar Beach has been taken care of." Mr. Williamson also thanked the Board for allowing him to go to Highway School. He gave a verbal report on the Highway School. He said that "all the signs need to be replaced because of all the new specs. We must show a plan that the signs will be put in place and within the next 10 years they want to see that all the signs replaced with Highway Flectivity Signs. We can do one road for approximately \$250.00 to replace the signs. " Also, some repairs need to be done to Highway Building. The Building and Grounds Dept. Committee needs to have a meeting to discuss several repairs. Also the Town Hall Building needs to have some repairs to it.

The trash cans are ready for the Town Park but have not been put in place yet. Jim Williamson said "the mud hole in the Park is dried up. We are going to do away with the ditch and putting run of crush in place. We have a piece of pipe left over from Bromka Road, and that will fit in there."

Supervisor Kaiser said he had not heard back yet from the surveyor for the Town Park.

Phil Griswold from Sewer & Water and I met last week to look at the flooding issue coming down through the park. Mr. Griswold recommends to wait till this fall when the leaves are off the trees. He will give us an idea of the slope to clean the ditch out to bring the water back to where it is suppose to go. Supervisor Kaiser is hoping that they can get the State DOT to help with the ditch.

Mr Coon wanted to know if they could paint some lines indicating a Pedestrian crossing on road at the intersection of First St. and Propsect St. Mr. Williamson said there is not enough call for one.

Also, he wanted to know if there could be a Town Justice sign posted for the Town of Romulus. We do not have one. Supervisor Kaiser will check into that. Another problem Mr. Coon wanted to ask about was "Can the Dog Control Officer take care of Feral Cats?" The answer is that the law does not apply to cats as it does to dogs.
