Zoning Officer Lee Hoagland had a concern about going on private property and have some unforeseen accident, being that he is contractual with the Town. Supervisor Kaiser told him that he would be covered by the home owners liability insurance. Supervisor Kaiser will have the Personnel committee look into this matter.

Supervisor Kaiser talked to Mr. DeGaray and they are suppose to meet sometime this week. Lodi has threatened to pull out completedly from South Seneca Ambulance Corp and that would mean a loss of quite a bit of money approximately \$17,000 or \$18,000. Even is the Town of Romulus agreed to the additional \$4000 some odd dollars, for the \$30 rate plus Lodi's share, the ambulance corp would still be \$12,000 short on their revenues according to Mr. DeGaray. Instead of working with us, he wants to argue with everybody and now has the real danger of Lodi just pulling out completely and hurting himself even more. It is a good sign that Mr. DeGaray wants to open up dialogue and

wants to resolve this issue. Brayton Foster said one good thing, if it is our idea to separate ourselves from their operations for liablility, probably seating a member on their board of directors is not a good idea. That would almost make us a part of their operation. We probably don't want that. I do think we should have some ability to hold some kind of auditing. I would like to make some progress that is reasonable and the board feels it is reasonable. I would like to pursue and not escalate this to some big major problem to cause us not to have ambulance service.

A new sign can be made over at 5 Pts C.F, or Williard DTC for the Town of Romulus at the end of Second Street.

I have received a couple of complaints from a woman who lives down next to the Catch Basin and she has said that the County Highway has not addressed it yet. I have tried Roy Gates at the County Highway Dept. but have been unsuccessful in reaching him. The lady's mother fell into the catch basin. The church has also not been done. The matter of the huge truck that is parked on second street has been given to the Highway Committee to check into.
