SECTION ONE. LEGISLATIVE INTENT. The intent of this local is to extend the existing one-year moratorium on the new construction of kennels and/or pet breeders in the Town of Romulus for an additional year, for a total of two (2) years, while the Town Board, the Town Planning Board, the Town Attorney and other entities continue their review of the standards under which large scale and/or commercial kennels or breeding facilities be permitted or regulated within the Town.

SECTION TWO. MORATORIUM EXTENDED. Local 1 of the Year 2008 of the Town of Romulus his hereby modified only as follows: "SECTION THREE: MORATORIUM" of said local law is hereby modified to read as follows: "Upon the effective date of this Local Law and continuing for two years thereafter, the construction or operation of any new Pet Breeder or Kennel facility or expansion of any existing Pet Breeder or Kennel facility shall be prohibited within the Town of Romulus." All other provisions of said Town of Romulus Local Law 1 of the Year 2008 shall remain in full force and effect, as if set forth more fully herein.

SECTION THREE. PARTIAL INVALIDITY. If any section of this local law shall be held unconstitutional, invalid, or ineffective, in whole or in part, such determination shall not be deemed to affect, impair, or invalidate the remainder of this local law.

SECTION FOUR. EFFECTIVE DATE. This local law shall take effect upon its filing with the Secretary of State.




