RESOLUTION NO. 91-20 ENACT HIGHWAY BUILDING RESERVE FUND REGULATIONS

WHEREAS the Town of Romulus has created various capital reserve funds for the purpose of mitigating the impact of future large capital purchases.

WHEREAS to ensure full transparency of the fund balances and activities it is deemed necessary by the Town of Romulus to establish formal written regulations for the control of those funds.

NOW, THEREFORE, BE IT

RESOLVED the following regulations are established for the management of the Town of Romulus Highway Buildings Reserve Fund.

HIGHWAY BUILDINGS RESERVE FUND REGULATIONS

Objective: To partially or wholly mitigate the impact of expenditures required to replace and/or effect repairs to any Town Highway Buildings.

Justification: The current Town of Romulus Highway Department building is aged and is inadequate for its purpose. The bays are too small for equipped vehicles. This requires storing the vehicles outside and results in additional work to un-equip and re-equip vehicles when repairs are needed.

In addition, the infrastructure is failing or has failed necessitating regular resupply of water and pumping of wastes.

The Town desires to replace this building (and associated structures) either by construction of new facilities or the acquisition, expansion, and/or repairs of adequate existing buildings.

Funding: The reserve will be funded by transfers from the General Fund and/or by budgeted amounts. Fund transfers (as opposed to budgeted deposits) shall be made by simple resolution of the Town Board.

Transfers will be made annually on or before January 31 of each year to a maximum amount of \$25,000 (twenty-five thousand) with no minimum, as available.

Utilization: Any single expenditures, or group of related expenditures, of \$25,000 (twenty-five thousand) or less may be approved by simple resolution. Any expenditures in excess of this amount will require a permissive referendum prior to the expenditure.

Review: The reserve will be reviewed by the Town Board at the annual Town Close-Out meeting to assess the reasonableness of the funds accumulated and to determine if the objective of the fund has been achieved.

If the reserve is no longer needed or there have been no expenditures for a period in excess of seven years, the reserve shall be considered for reduction or liquidation and closure.

In addition, investment of reserve funds shall be at the discretion of the Town Chief Financial Officer. Fund balances and investment amounts and income will be tracked in accounts specifically created for that purpose. Fund balances and investment gains and/or losses will be reported monthly to the Romulus Town Board.

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.
