RESOLUTION NO. 106-20 REAL PROPERTY TAX EXEMPTIONS RENEWAL

WHEREAS the Town of Romulus has previously allowed for certain real property tax exemptions for Seniors over the age of 65 pursuant to Real Property Tax Law section 467 and those with Disabilities and Low Incomes pursuant to Real Property Tax Law section 459-c; and

WHEREAS New York State Governor Cuomo has issued Executive Order 202.83, which allows for the governing body of an assessing unit to adopt a resolution directing the assessor to grant exemptions pursuant to such section on the 2021 assessment roll to all property owners who received that exemption on the 2020 assessment roll, thereby dispensing with the need for renewal applications from such persons, and further dispensing with the requirement for assessors to mail renewal applications to such persons.

NOW, THEREFORE, BE IT

RESOLVED the Town of Romulus Town Board hereby directs the Town Assessor to grant exemptions pursuant to Real Property Tax Law sections 459-c and 467 on the 2021 assessment roll to all property owners who received those exemptions on the 2020 assessment roll.

BE IT FURTHER RESOLVED the Town of Romulus Town Board hereby dispenses with the requirement that the assessor mail renewal applications to such persons.

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.
