Romulus Town Board Meeting Minutes – April 21, 2021

Roll Call – All present

Petitioner George Gedon East Lake Rd
Concerned about activities above their property – water mitigation
Spoken to Dave Hayes and Daryl Morrell

What is happening? Is an engineer involved?
Water under Waterview and East Lake Rd

Daryl installing culvert pipes
3 more sections to install, has this been cleared by an engineer?

Daryl following Matt Everdyke's directions
Gabion rock added, has minimum 25-year lifespan and slows water flow
Additional rock to be added (both gabion and large stone at outlet)
Check dams to be installed
All will further slow water

150 feet between pipe outlet and outlet under road - will slow water

Jeff Bond – property was initially very wet, needed to change flow of water, and clean out ditch
Initial solution was to connect 10" pipe to under road, also connected 4" pipe
Has discussed with several long-term residents and there does not seem to be a significant water issue

Ann Jardine – Lakeshore resident, chairing storm water management committee

Town will complete its obligations. HOA to discuss internal actions.
