RESOLUTION NO. 21-070 LOCAL LAW 4 - PROHIBITING THE LOCAL SALE AND ON-SITE CONSUMPTION OF RECREATIONAL MARIJUANA

WHEREAS the Town of Romulus desires to act pursuant to the recently enacted New York State legislation (S.854-A/A.1248-A) authorizing adult use, retail sale, and commercial on-site consumption of recreational cannabis (marijuana).

WHEREAS the above titled legislation allows the Town of Romulus, as a municipality, to enact legislation prohibiting retail sales of recreational marijuana, the commercial on-site consumption of recreational marijuana, or both within its borders.

WHEREAS a public hearing was duly held on August 18, 2021, at the Romulus Town Offices and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof, and

WHEREAS after due deliberation, and consideration of the comments submitted the Town Board of the Town of Romulus finds it in the best interest of the Town to adopt said Local Law.

NOW, THEREFORE, BE IT

RESOLVED the Town of Romulus is enacting Local Law 4 of 2021 prohibiting the retail sale of recreational marijuana and the commercial on-site consumption of recreational marijuana.

BE IT FURTHER RESOLVED that this resolution is subject to permissive referendum and will take effect 45 days from the date of adoption or after the permissive referendum process is completed.
