TOWN OF ROMULUS TOWN BOARD MEETING November 16, 2022

- 1. Call to order by Deputy Supervisor Michael Joslyn at 1805 on November 16, 2022
- 2. Roll call was taken. All members are present except for Supervisor Hayes, who was sick and excused.,
- 3. The Pledge of Allegiance and a moment of silence for all.
- 4. A motion was made to open the Public hearing for the Tax Levy Hearing by Councilman Stacey Bennett and seconded by Councilwoman Melody Collinsworth.
