



# TOWN OF ROMULUS

## Resolution 22-048 – Authorize Town Clerk to Advertise Public Hearing Under Town Law §202-b

**WHEREAS** the Town Board of the Town of Romulus, New York (the “Town”) previously requested HUNT Engineers, engineers duly licensed by the State of New York, to prepare a map, plan and estimate of cost for the improvement of facilities of the Willard Water District in and for the Town, consisting of replacing approximately 8,500 feet of deteriorating water mains that have experienced several failures and inability to provide required fire flows to the community and associated connection piping incidental thereto; and

**WHEREAS** said map, plan and estimate of cost are on file in the office of the Town Clerk for public inspection and the estimated maximum cost of such improvement is Three Million, Eight Hundred Eighty-eight Thousand, Nine Hundred and Fifty Dollars (\$3,888,950.00); and

**WHEREAS** it is now desired to call a public hearing on said proposed improvement pursuant to Town Law §202-b.

**NOW, THEREFORE, BE IT RESOLVED** that a meeting of the Town Board shall be held at the Town of Romulus Offices, 1435 Prospect Street, Willard, NY 14588 on the 21st day of September, 2022 at 6:00 p.m. for the purpose of conducting a public hearing on the proposed increase and improvement of the facilities of the district in the Town, as described in the preambles hereof, at which time and place the Town Board will hear all persons interested in the subject thereof concerning the same.

**BE IT FURTHER RESOLVED** that the Town Clerk is hereby authorized and directed to cause a notice of said public hearing to be published in the official newspaper of the Town and posted in the manner prescribed by law, which notice shall be in substantially the following form, to wit:

PLEASE TAKE NOTICE that the Town Board of the Town of Romulus will meet at the Town of Romulus Offices, 1435 Prospect Street, Willard, NY 14588 on the 21st day of September, 2022 at 6:00 p.m. for the purpose of conducting a public hearing on the proposed increase and improvement of the facilities of the Willard Water District consisting of replacing approximately 8,500 feet of deteriorating water mains that have experienced several failures and inability to provide required fire flows to the community and associated connection piping incidental thereto, at an estimated maximum cost of Three Million, Eight Hundred Eighty-Eight Thousand, Nine Hundred and Fifty Dollars (\$3,888,950.00) pursuant to a map and plan on file in the office of the Town Clerk and available for public review, at which time and place said Town Board will hear all persons interested in the subject thereof concerning the same.

**BE IT FURTHER RESOLVED** that this Resolution shall take effect immediately.
