Minutes, Town Board — Wednesday, August 16 th, 2023, at 6:00PM

1. Call to Order at 6:00PM
2. Roll Call — Bennett, Hayes, Joslyn, and Councilwoman Collinsworth were present. Joe Brodnicki was absent. There was a quorum.
3. Pledge of Allegiance and a Moment of Silence for Councilman Brodnicki passing.
4. Steve Bromka (Sunset Court) Supervisor Hayes and Councilman Joslyn promised That they would have the completed paperwork by the next board meeting. Mr Bromka was looking forward to seeing when title searches will be completed. The Town Attorney was not present at this time of the meeting. Resident Donald Reinshaen was next to speak about Baptist Church Rd being open to the public again with Mr. Martin taking his fence down. Also wanting to know who will take care of the road maintenance like plowing in the winter. HYWAY Supervisor stated that he has always plowed what the Town owns, and it shall continue that way. We have no right to go to Mr. Martins property. Mr Reinshaen was advised that if he had a problem with Mr. Martin removing his locks on the gates then he should report it to law enforcement and let them handle the problem. The Town has no say in this matter.
